

Health Care Reform

Health Care Reform legislation is the focus in the U.S. Senate at this time. Many components of the bill are consistent with AAUW's stated position that reform should:

End the practice of gender rating;

Require coverage of women's reproductive health services;

Ensure access to and coverage of access to preventive services and care.

A number of amendments have been introduced, including one by Senator Ben Nelson (D-ND), mirroring the amendment by Rep. Bart Stupak (D-MI) in the House bill, that would effectively end coverage for abortion services and instituting what amounts to a domestic gag rule. The Nelson Amendment did not pass, thanks in part to floor speeches by California Senators Feinstein and Boxer who forcefully spoke about the implications for women of such a restriction on reproductive freedom. This is a positive step in the fight for reproductive health care coverage, but the battle isn't over yet; language similar to the Stupak and Nelson amendments could still be included in the final version of the Health Care Reform bill.

There have been numerous other amendments to this complex bill, and debate continues on this monumental legislation. A very useful resource with detailed analyses of all the key aspects of coverage can be found online at the Kaiser Family Foundation website, www.healthreform.kff.org. It is updated frequently and contains helpful comparisons of the Senate and House bills. Current topics explored in depth include:

Implications for Women's Access to Coverage and Care; The Medicare Buy-in Option for Older Uninsured Adults; Immigrants' Health Coverage and Health Reform: Key Questions and Answers.

When the Health Care Reform bill passes in the Senate, a joint conference committee will work to integrate the Senate and House bills into a single bill for President Obama to sign.

Please contact Senators Dianne Feinstein and Barbara Boxer, thanking them for their vote on the Nelson Amendment, and asking them to continue to work for inclusion of the principles that AAUW supports in the Senate Health Care Reform Bill.
