PAYCHECK FAIRNESS ACT

This act #S 182/HR 12 must pass before the end of this year or it must begin all over again to go through both houses of Congress. AAUW has been a strong advocate of this bill which provides for:

- Stronger incentives for employers to follow the law and offer equal pay

- Stronger penalties for violations

- Empowering of women to negotiate for equal pay

- Prevention of retaliation for employees asking about organizational wage practices or disclosing their own wages to other employees

- Strengthening of outreach, education and enforcement efforts

Please contact Senators Dianne Feinstein (415-393-0707 or Feinstein.senate.gov) and Barbara Boxer (415-403-0100 or boxer.senate.gov) to urge them to vote to pass the Paycheck Fairness Act.

AUTUMN FESTIVAL BIG SUCCESS FOR LAF

The Autumn Festival, held at Ursula Batz's home, was a great success. We raised over \$1,000 for the Legal Advocacy Fund! More than 50 people attended the event which featured Elizabeth Kristen, Legal Aid Society lawyer and branch member, speaking about a Title IX class action law suit in Chula Vista, California, in which she has been involved for about 8 years. She had a power point presentation showing the faces of the litigants, mostly Latina girls, and the poor softball facilities for the girls at this high school compared to the manicured field and facilities for the boys' baseball team. This made the presentation personal for the audience and more than just statistics.

Elizabeth also talked about the "Program In A Box" which branches can get from AAUW to replicate in their own areas. This past year, Liz Bathgate chaired such a program for our Branch and the general public at the Castro Valley Library. Presenters were the Women's Athletic Director at Call State East Bay, University, one of the student Volley Ball players, and a High School PE Teacher. One of the outcomes of this program is that several branch members are now attending CSUEB Women's Volley home games to show their support of women's athletics at the university.

Many thanks to Dave Krug who played background piano music. As in the past, our wonderful members brought delicious light finger food to go with the warm mulled cider and wine. My committee Sandy Boswell, Robin Peterson, Shirlee Lustig, Pat Sutter, Evelyn Gertler, and Linda Slater were enthusiastic planners, doers and helped with the cleanup.
