New Information

Case Update

On November 19, oral arguments were held for the LAF-supported case <u>*Cioca v.*</u> <u>*Rumsfeld*</u>. The plaintiffs are 28 current or former members of the military who allege that they were raped by coworkers and that the defense secretary's failure to act on the issue of sexual assault in the military amounts to a violation of their constitutional rights. On December 13, a U.S. district court judge <u>granted</u> the Department of Defense's motion to dismiss the case, which argued that the Supreme Court has found that members of the armed forces cannot sue the military for injuries incurred while serving, including sexual assaults.

In the next month, Susan Burke, the lawyer for the plaintiffs, <u>will file an appeal</u> and ask the appellate court to overturn the dismissal. Since filing the original lawsuit in early 2011, Burke has heard from 400 other survivors, many of whom could be part of future suits. Burke will meet with the LAF Committee in early January to discuss the case and its importance.

Four LAF Campus Outreach Events

This fall, four AAUW branches received LAF grants to tackle sex discrimination in their communities by holding <u>LAF Campus Outreach</u> programs. The programs were collaborations with local campuses and focused on issues such as the gender pay gap and Title IX and athletics.

- 2. AAUW Wilmington (NC) Branch and the University of North Carolina, Wilmington
- 3. AAUW Kerrville (TX) Branch and Schreiner University
- 4. AAUW Arlington (VA) Branch and Marymount University

GREAT NEWS!!

Cal State East Bay has become a university partner with AAUW National. For the sum of \$130 they joined our network. This makes all of their students eligible to become e members of AAUW at no cost to them. All they have to do is register online. Thru this membership they have access to white papers and legislative issues background and opinion papers online in the public policy section of the AAUW website. They will also receive a 15% discount on exam preps through The Princeton Review.

More important is that they can also become members of our branch and the state AAUW. This means that we may be able to offer a couple of programs on campus, which are of interest to the students. One is called the \$tart \$mart workshop where students will be trained to negotiate a salary and benefits package as they go out seeking employment in their field.
