# PRESIDENT'S MESSAGE

This has been a very busy summer for our branch. In July Helene Carr and I went to Chabot College to meet with their new President, Dr. Susan Sperling. This meeting was made possible by a member of our branch, Isobel Dvorsky, who is on the board of the college. We found Susan very receptive to the idea of Chabot becoming a College Partner Member with AAUW National. On August 28th Helene and I will meet with Susan and three professors to talk about programs that we can do on campus for their students. These might include programs on Sexual Harassment, the showing of the movie Miss Representation and/or the movie Invisible War.

Starting Monday August 20th, we will have AAUW members from our branch, who are volunteering their time on the Chabot Campus to register voters. This is a national program called WOMAN-TO-WOMAN Voter Turnout. (Helene and I went to this afternoon training at our state convention in April). The idea is to get these millennial of women voting. Many of these young women do not realize how hard our ladies worked for over 50 years in order for them to have this right. We need them to understand that every vote counts.

Your branch board has met three times over the summer and produced a budget for next year, which you can find in this newsletter. We need to vote on this at our first meeting that will be the Membership Pot Luck Picnic on September 22. We also have setup a Program Schedule Fall 2012-Winter 2013, which is also in this newsletter and I urge you to put the events you are interested in attending on your calendar right now!

I was asked by National to listen to a conference call with staffers at the White House. The staff had nothing but kudos for our National AAUW Lobbyist, Lisa Maatz. I once had the opportunity to hear her speak in Alameda on the issues of interest to AAUW at that time. She spoke about bills, senators and congressmen for two hours without a note. She is truly a remarkable woman and we are so fortunate to have her on the side of women! The call with Washington covered the Violence Against Women Act. This passed the Senate with bipartisan support, but when it reached the house they gutted many provisions from it and watered it down so much that it is useless in this new form. It especially does not cover immigrant women. The White House is also working on gender based violence around the world thru the U.N. The other main topic of discussion was the change to health care laws for women which starts now. Women will have access to 5 new services at no co pay. These include diabetes screening for pregnant women, access to contraception, STI testing and counseling and check ups and screening.

AAUW is truly a vital organization for all women to support. I had the opportunity to be a dorm mom at Tech Trek this summer. It was an eye opening experience to see all those 7th grade girls get so excited about science and math. This is one of the best programs we can support with our dollars.

#### LAF-Supported Military Sexual Assault Cases Featured on HBO

#### **Title IX Anniversary**

June 23 marks the 40th anniversary of the passage of <u>Title IX of the Education Amendments of 1972</u>. AAUW was instrumental in its passage, and the law resulted in an increase in girls' sports participation and the number of girls and women in the fields of science, technology, engineering, and mathematics. It also offers protections to all students against sexual harassment and sexual assault. #### **AAUW Awards Four LAF Campus Outreach Grants**

- A \$tart \$mart salary negotiation workshop at the University of Maryland, Baltimore County, in the fall, co-hosted by the AAUW Baltimore (MD) Branch
- A \$tart \$mart salary negotiation workshop at Bowling Green State University in January made possible by the Louise Sause Campus Outreach Grant and co-hosted by the AAUW Bowling Green (OH) Branch
