In case you forgot, all of the money that we make from the benefit performance of a play goes to Tech Trek, with the aim of encouraging girls who have that camp experience to consider pursuing a career in science or math. Tech Trek is very close to my heart, and I wish it were close to the hearts of all our members. If it were, we would already have sold more than 23 tickets to Eleemosynary. That's the grand total of all the tickets we have sold so far. In order to have a grant from California Conservatory Theatre in the future, we need to sell at least 50 tickets.

If you have ever been to a performance at that little theatre, you know it is easy to see and hear from every seat in the house because there are only 67 seats. The tickets are just \$20 each, a real bargain! Compare that with the cost of tickets for any play being performed in San Francisco. Since I've attended countless plays at California Conservatory Theatre over the years, I know that many of the actors and actresses in CCT productions have had professional experience, and even the amateur cast members have been admirable.

Our benefit performance—on Thursday, December 10—is for, *Eleemosynary*, a play about three generations of women. The play's title comes from the spelling bee in which the granddaughter becomes the National Spelling Bee champion. Her mother is a research scientist who fears love and life. Her grandmother overflows with love and fears nothing. If you are a granddaughter, a daughter, a mother, or a grandmother, then this play is for you! Incidentally, *Eleemosynary* won the Los Angeles Drama Critics Circle Award in 1997.

## AAUW-CA: Bylaws Amendment Changes How We Elect Officers

At their October meeting, the AAUW CA Board of Directors voted to accept amended bylaws proposed by Jo Harberson, Bylaws Director, and her committee. One of the important changes in these bylaws is the election of state officers by the members of AAUW CA.

Under the previous bylaws, the sixteen directors were elected by the members (eight each year), and the officers were elected by those directors among themselves. The amended bylaws call for the four officers (President, Vice President, Secretary, and Chief Financial Officer) to be elected directly by the members. The amended bylaws can be found on the website in the **Forms & Documents** section, Under **Governance.** Or by clicking [HERE](#).

At our state convention and annual meeting, April 30-May 2, 2010 in San Ramon, members present will elect the President, Vice-President, Secretary and CFO as well as General Directors. The President and Secretary will be elected to a two-year term. The Vice-President and CFO will be elected to a one-year term **this election only** in order to establish a rotation in which only two of the officers will be elected each year and all officers will be elected to two- year terms.

The deadline for submitting nominations for officer or director is December 1, 2009. The *Call for Candidates* and the *Vita* forms are available on the website in the **Forms & Documents** section, under **State Leadership.** Or by clicking [HERE](#). Please identify the leaders in your branch and encourage them to run.

A letter with further details has been mailed to every branch president in California. A postcard stating the change will be mailed to every member in California in early November.

## AAUW FUNDS *By Dee Donaldson*

The Educational Foundation, the Legal advocacy Fund and the Eleanor Roosevelt Fund are now housed under the name of "AAUW Funds". The upcoming Holiday Party has as it's roll to raise money for Fellowships given to women. Gifts to our various scholarships are all tax deductible under the 501 (c) 3 federal tax code. The AAUW was founded in 1881 and is part of an international organization for advancing the role of women and girls through advocacy education and research.

In the U.S. there are 1300 branches plus 550 college/ university institution partners...

The Hayward/Castro Valley branch was founded in 1941 and now has 125 members. All our activities and programs have this Mission: *to advance equity for women and girls through advocacy, education and research.*

Membership is open to any woman or man with an Associate or Baccalaureate Degree; a Student Affiliate membership is open to students who are pursuing these degrees.

One of our many programs is Tech Trek which is formed to send 7th grade girls to a Math/Science camp at Sonoma State during the summer before 8th grade. The girls are recommended by their math and science teachers. They stay there 6 days and nights and are instructed by female teachers and women working in those fields. They love it! They learn a lot by doing all sorts of math and science experiments. A number of girls have gone on to university to study these subjects and who find employment in these fields.

Our Women in History program brings branch members into the schools to play roles of famous women who have changed the way women are perceived because of their rolls of leaders in various fields. They dress as the women would have dressed in their day and speak about the various wonderful things that woman had done in past days to children in our local schools.

These are things that inspire our girls to have meaningful futures and they inspire our members to promote them.

## Holiday Boutique Recap

On Sunday, November 8th, our AAUW Branch hosted its 1st Annual Holiday Boutique in San Lorenzo. This was not just another craft fair. Oh no, it was a fundraiser for our Local Scholarship program, that provides one scholarship a year to a deserving graduate of Chabot College who needs financial assistance to transfer to a 4-year university to complete her degree.

The Holiday Boutique was my brainchild, so I became chairperson of the event. In August my fabulous committee stepped up to help. My heartfelt thanks to Debby Westcott, Nancy Turner, Helene Carr, Sandy Boswell, and later Robin Peterson, who operated the goodies booth that brought in \$365! Wow! Together we brought the idea to fruition, with planning, preparation and plenty of help from members the day of the boutique. Thanks to Ursula Batz, Dee Butner, Dee Donaldson, Ruth Kuftin, Estelle Rademan, John Hendry (Nancy's husband), Larry Boswell (Sandy's husband), Bonnie Smith, Ruth Leth, Mary Graw and Liz Bathgate for all of their assistance. Without all of you this would not have worked! A total of 18 vendors, selling jewelry, purses, scarves, shawls, beauty products, baskets, ceramics, stained glass, pressed flower pictures, honey, girls hair ornaments, baby products and cookware set up their tables in the San Lorenzo Community Hall prepared to sell their wares. They came mostly from the East Bay, but one from as far as Antioch. Debby, Nancy and I found them through word of mouth,

internet searches, flea markets/street fairs and advertisements.

We think we ended up with a good mix of sellers (though some comments said there was too much jewelry, something to think about for next year).

To participate each vendor paid a \$20 table fee. This just about covered all our costs for venue, advertisement, and decorations. On top of that each vendor generously gave 10% of their sales for the day, and a gift for the donation drawing which alone raised \$163. All in all our profit was \$793. Not bad for our first year.

In retrospect it was definitely worth it, for a couple of reasons: (1) it gave our Branch local exposure. I find that most people don't know who or what AAUW is or does. This event helped; (2) the community supports our Local Scholarship program. 172 attendees (including vendors and members) bought gifts, participated in drawings, and ate goodies. More than just our the members to support our programs; and (3) we gained new members for our branch. Liz Bathgate enlisted four (4) new members out of this one event.

I'm so excited! These events do require a lot of teamwork and planning, but the results justify the means. I hope you got a chance to stop by. I look forward to getting you all involved next year.

## Vendors at Our Holiday Boutique

When I saw the beautiful items displayed at the Holiday Boutique, I knew I had to write about some of the vendors and the beautiful items they had for sale. Although I did not get information about all of them, I want to give our branch members a taste of what was available.

Gene Krueger is a potter who has been making pottery for only a few years. Although he is a senior, he was not aware of this side of himself until he started going to classes at the San Leandro Senior Center to learn about pottery making. He now has his own kiln and potter's wheel, but continues to learn new techniques at the Senior Center. The technique he is now working to perfect is called glazing with crystals. He displayed many pots and bowls that he had made, including some with the crystal glazing technique.

Yvette McIntyre, of Simplicity, is a returning student at Chabot College, while her daughter attends Los Angeles City College. Yvette makes framed pictures of pressed flowers and leaves. She also makes sets of coasters using pressed flowers in glass. Yvette is one of the women who joined our branch at the Holiday Boutique. We look forward to seeing her at our meetings.

Florence Cisneros, of Craft Creations, knits and crochets baby jackets, booties and blankets and clothes for Barbie dolls. She also makes scarves, and fleece pillows and blankets for children, and tiny booties for favors at baby showers.

Radonna Scott, one of our new members from the Membership Picnic, showed her Just Jazzy fashion accessories. She had many items that one can add to any outfits to make them sparkle. I especially liked her soft colorful scarves.

Claire Cade brought cottage industry shawls, scarves, wraps and bags made by women in India, the Himalayas and Bali. She travels regularly to Asia and these women look forward to show her what they have made since she was last there. They use the old looms for making traditional patterns, sometimes using modern threads, and sometimes using silk. The blanket wraps and shawls of acrylic fiber with traditional patterns were warm and soft, and yet are machine washable. I was especially interested in this vendor's items, because she is helping to support women who are improving their own lives with these cottage industries. Alameda County Bee Keepers had a display and sample tastes of their honey. They had a glass display showing the bees in a hive making the wax comb and showing some of the honey. I learned that they are regular vendors at the Hayward Farmer's Market, and have been written up in the Tri City Newspaper.

We had many more vendors who had everything from health products, to jewelry, to purses and bags, and Tupperware. I know you all will want to attend our Holiday Boutique next year to do some of your shopping from these interesting vendors.
