# LAF Update-- Lilly Ledbetter Fair Pay Act Signed Into Law by President Obama

You all may recall that AAUW-LAF supported Lilly in the lawsuit. Background. The Lilly Ledbetter Fair Pay Act, which states that the 180-day statute of limitations for pay discrimination resets with each new discriminatory paycheck, was signed into U.S. law on January 29, 2009, by President Barack Obama.

The law was enacted in response to Ledbetter v. Goodyear Tire & Rubber Co., 550 U.S. 618 (2007), a U.S. Supreme Court decision holding that the statute of limitations for filing an equal-pay lawsuit begins at the date the pay was agreed upon, not at the date of the most recent paycheck, as a lower court had ruled. This precluded lawsuits by plaintiffs who alleged ongoing pay discrimination but who did not discover it until years after the discrimination began.

A bill to amend the statutory limitations period and supersede the Ledbetter decision failed to pass in the 110th Congress, and was re-introduced in the first session of the 111th United States Congress. The bill (H.R. 2831 and S. 1843) was defeated in April 2008 by Republicans in the Senate who cited the possibility of frivolous lawsuits in their opposition of the bill and criticized Democrats for refusing to allow compromises. The bill was reintroduced in the House in January 2009 (as H.R. 11 and S. 181), where it passed with 247 votes in support and 171 against. The Senate voted 72 to 23 to invoke cloture on S. 181, on January 15, 2009. (The vote to invoke cloture ends debate on a bill, and usually leads to a final vote within a few days.)

The Lilly Ledbetter Fair Pay Act passed the Senate, 61-36, on January 22, 2009. The votes in favor included every Democratic senator (except Edward Kennedy of Massachusetts, who was absent from the vote because of health issues) and all four female Republican senators. Every male Republican voted against it except Pennsylvania's Arlen Specter, who voted for it.

With the recent passage of both the Lilly Ledbetter Fair Pay Act (H.R. 11) and the Paycheck Fairness Act (H.R. 12), the U.S. House of Representatives demonstrated a firm, bipartisan resolve to attack wage discrimination on all fronts. "This Senate victory on the Ledbetter Fair Pay Act is hard fought and celebrated, but it still falls short of our ultimate goal," said AAUW Executive Director Linda D. Hallman, CAE. "While passing the Ledbetter bill is an important down payment on an election year promise to address pay equity vigorously, AAUW remains determined to see the Paycheck Fairness Act follow the same path and become law."

The Paycheck Fairness Act would provide additional tools to deter wage discrimination, closing loopholes in the Equal Pay Act through stronger penalties for violations; strengthening federal outreach, education, and enforcement efforts; and prohibiting retaliation against workers who ask about employers' wage practices. The Ledbetter Fair Pay Act, will address the U.S. Supreme Court's wrongheaded decision in Ledbetter v. Goodyear Tire & Rubber Co., restoring the long-standing interpretation of civil rights laws and EEOC policies that allowed employees to challenge any discriminatory paycheck they received.

#### **NEWS FROM AAUW IN WASHINGTON DC**

As the recession has deepened, we at AAUW have been stepping up our efforts to fight for working women and their families. I wanted to take this moment to fill you in on our latest work, update you on our progress, and keep you informed on where we stand on these critical issues.

For the last several months, AAUW has been lobbying members of Congress on our top priorities for the American Recovery and Reinvestment Act - the recovery bill -which include investments in higher education, school construction and modernization, affordable healthcare, targeted tax credits, and direct appropriations to states and localities to support critical services. We are pleased to report that AAUW was successful in maintaining most of our key priorities in the compromise measure, including:

- A valuable tax credit to "Make Work Pay" for American families and an expansion of the Child Tax Credit to target more families in need especially those in poverty.
- The inclusion of an extension and increase of current unemployment benefits, which will help many hurting workers facing an even tougher job market and also represents funds that will quickly go back into the economy.
- Almost \$20 billion in appropriations for the Supplemental Nutrition Assistance Program (SNAP) because, in addition to feeding the hungry, food stamps are dollar for dollar by far the most stimulative provision in the recovery and reinvestment bill.
- The "American Opportunity Tax Credit," a \$2,500 tax credit for college tuition and other expenses, providing a targeted investment that will encourage individuals to retrain and retool through higher education which will in turn improve their earning potential and career competitiveness. People without college degrees are much more vulnerable to being laid off than those who have this important credential, providing further evidence that the AAUW priority of investing in education is money well spent, period.
- A vital increase in the maximum Pell grant award of \$500 for the 2009-2010 school year, as well as additional funds for workstudy programs, helping millions of students go to college and stay in college.
- Providing meaningful COBRA subsidies, which will allow more American families to be able to maintain their health insurance and afford valuable preventative care after they've been laid off, which could help to avoid not only heartache but bankruptcies in the future.

While engaging in intense lobbying efforts on the recovery bill, AAUW also took the lead in promoting another form of economic stimulus: pay equity. I was so proud to have a front-row seat at the White House to watch our new president sign the Lilly Ledbetter Fair Pay Act fixes the Supreme Court's disastrous 2007 Ledbetter decision, but that's just a down payment on the truly meaningful change needed to end the pernicious wage gap. That's why AAUW hosted and led a key coalition meeting for the Paycheck Fairness Act. This critical legislative update to the 45-year old Equal Pay Act takes a number of steps to deter wage discrimination and to empower women to negotiate for and achieve equal pay in the workplace. There is more in the works, so watch for our next update

#### Highlights of Proposed AAUW Bylaws

by Sandy Kirkpatrick, AAUW-CA Parliamentarian & AAUW Bylaws Committee Member AAUW's strategic planning process began in 2005, with a restructuring approved unanimously at the 2007 AAUW Convention. To complete this restructuring, newly revised bylaws will be presented for approval at the 2009 AAUW Convention at St. Louis.

#### These bylaws:

- streamline the current bylaws and move administrative details to policies and procedures;
- provide more flexibility on all levels (branch, state, and national); and
- provide more avenues for all members to participate in the organization, in particular giving every member a vote on national business.

#### What will NOT change:

- mission-based activities and programming, including the work of the Educational Foundation, Legal Advocacy Fund, and Leadership Training Institute;
- public policy advocacy through the newly named "AAUW Action Fund;" and
- the unique mission and grassroots strength of AAUW.

#### Summary of Major Changes:

- 1. <u>ONE MEMBER-ONE VOTE</u>. Instead of using a delegate system, every member will have a vote. Members who cannot attend meetings and vote in person will be able to vote by all methods approved by the corporate code of the District of Columbia and the Board (i.e., mail, phone, FAX or electronically).
- 2. <u>ONE BOARD</u>. AAUW and EF boards are merged into one board with authority over all aspects of AAUW activity, including:
- delivery of the mission through programs and policies;
- setting membership dues (part of financial administration oversight);
- appointment of the directors of the AAUW Action Fund, for voter education and related political activities; and
- appointment and oversight of AAUW committees and task forces, including determining the process for the awarding of fellowships and grants.
- 3. MEMBERSHIP OPEN. Membership is open to any individual supportive of the mission, without regard to college degree status, and to partner members. Partner membership broadens the current college/university membership category to include the possibility of other institutions or organizations that meet the criteria. Open individual membership provides an equal opportunity for all to join, in recognition that one does not need to have educational credentials to work for women's education.
- 4. <u>STRUCTURAL FLEXIBILITY</u>. Branches and states will not be required to make any changes if their current structure works well for them. However, the new bylaws mandate only an administrative and financial contact person from each branch/state, allowing the branches and states to create the structure and leadership positions that make the best use of their resources to fulfill AAUW mission. ## **MEMBERSHIP UPDATE**

Another year has gone by and again we are asking members to renew their membership in AAUW. This year you have an opportunity to renew your membership by either mailing your check to me, *Erica Campisi*, at **841 Hampton Road, Hayward 94541**, or using the electronic method after May Ist. After that date you can send your money electronically to Washington (the full \$80) and they will process your dues check. State offices and branches will be reimbursed monthly. This new way of payment is optional. National has worked on this for quite some time and they hope that this new way of membership dues payment will eliminate some of the paperwork and increase efficiency.

Another news item that came from National is that <u>effective April 1, 2009</u>, of the \$49 AAUW National individual member dues - \$46 is tax deductible, (payable to "AAUW", 501© 3) charitable organization. Three dollars goes to support AAUW's Lobby Corps and election-related activities and are not tax deductible. You still need to pay the full \$49.00 to AAUW-National – Students Affiliate dues will continue to be \$17, \$16 of which will be tax deductible for the same reason. Member-at-Large will remain at \$49.00.

AAUW is giving you a choice of either using the self-addressed stamped envelope that was mailed to you to for your membership dues renewal, or wait until May 1st to use the new method of sending your check electronically to AAUW National. As soon as more information becomes available I will update you via the newsletter

Also, if you are unable to pay the full membership amount, \$80.00, please remember that we have an Angel fund – which can be used to make up any shortage.

#### **FLOWERS UPDATE**


