On **October 7th**, Lisa Maatz, the AAUW Director of Public Policy and Governmental Relations and Interim Director of the AAUW Legal Advocacy Fund, will speak at a workshop sponsored by the Alameda County Interbranch Council of AAUW.

As AAUW's top policy adviser, Lisa Maatz will discuss how she works to advance AUW's priority issueson Capitol Hill, through the executive branch, and in coalition with other organizations. Maatz has done similar work for the NOW Legal Defense and Education Fund and the Older Women's League, and was a legislative aide to U.S. Congresswoman Carolyn Maloney (D-NY). Maatz's areas of expertise include gender equity in education, Title IX, retirement security, pay equity, and other civil rights issues related to women and girls. Her presentation will focus on Title IX, pay equity, abortion rights and hot topics from the "Hill." She will also discuss how AAUW's public policy work is implemented, and how that work is driven by AAUW's mission through our member-adopted public policy program.

This event will be held on **October 7 from 2 to 4 p.m**. at the new Alameda Library, 1550 Oak Street (parallels Park Street –central Alameda). **Parking is free.** Attendance donation will be \$5



WHAT DOES OUR NATIONAL AAUW ORGANIZATION DO?

In an article about Pay Equity which appeared in the San Francisco Chronicle Sunday September 2nd the following was stated!

" A study this spring by the American Association of University Women shows that differences in pay between men and women show up right away: only one year after college graduation, women earn 20% less than their male counterparts. Within 10 years, the gap expands to 31%. And the gap exists even when women have the same degrees, majors and careers as men. Even after adjusting for parenthood, choice of field, hours worked and the like, a quarter of the gap remained – inexplicable, the AAUW suggested but for sex discrimination".

This is but one of the studies conducted by AAUW which concern women in our country. Our National organization has done many studies of girls and women in school as well as in the workplace so that this information can be brought to the public's attention. We all need to support their efforts to see that women are not left behind!
