New LAF Case Challenges Gender Discrimination at the University of Tennessee

We're proud to announce LAF support for a new case, *Moshak v. University of Tennessee*. The lawsuit was filed in 2012 by Jennifer Moshak, Heather Mason, and Collin Schlosser, former employees of the University of Tennessee's women's athletic department. The plaintiffs allege sex discrimination and unlawful retaliation under Title VII of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, and the Equal Pay Act of 1963. They claim that they were unlawfully discriminated against and eventually forced out of their positions during a university-led merger of the women's and men's athletic departments.

Schlosser and Mason argue in part that they were fired by the university after making internal complaints alleging unequal pay between the women's and men's athletic departments. Moshak claims that she was demoted, marginalized in the department, and then forced to retire. The plaintiffs also say that during the merger the vast majority — 86 percent — of terminated employees were either women or were men in the women's athletic department.

Veterans Dismissed in Military Sexual Assault Case

Last month, the D.C. Circuit Court of Appeals ruled against a group of veterans that had sued the U.S. military for alleged acts of sexual assault while the veterans were on active duty. In the LAF-supported case, *Klay v. Panetta*, the plaintiffs said that U.S. military officials tolerated sexual predators in their ranks and antagonized service members who reported rape, sexual assault, and harassment. The plaintiffs argued that this culture of sexual assault violated their constitutional rights. In 2013, a U.S. District Court granted the defendants' motion to dismiss the case, saying that the plaintiffs' injuries were incident to their military service and that the court was prevented by legal precedent from ruling on a military matter. The plaintiffs appealed to the D.C. Circuit. Following court arguments held in February, the circuit court affirmed the district court's dismissal of the case.

AAUW is very disappointed in this latest ruling. The plaintiffs and their advocates are deciding how to proceed.

Article Spotlights Confidential Survivor Advocates as a Much-Needed Campus Resource

This fall University of California, Berkeley and many other higher education institutions are hiring confidential survivor advocates to help address campus sexual violence. "Instead of bouncing around among various resources, you can have someone you work with throughout the process," said Anne Hedgepeth, AAUW government relations manager. "When survivors have an advocate, they get better medical treatment and they understand their options better." Recognizing the success of these advocates on campuses where they already exist, a White House task force report in April recommended hiring confidential advocates as a positive step schools can take to meet the needs of survivors on campus.

Obama Administration Announces Review of Contraceptive Coverage Accommodation

Today the Obama administration <u>announced</u> proposed revisions to regulations for the Affordable Care Act that would change how certain workers receive insurance coverage for contraception. Under the proposal, a closely-held for-profit business with a religious objection to contraception would notify the Department of Health and Human Services (HHS) of its objection, and HHS would work with the insurance company to ensure continuing contraceptive coverage without co-pay for the business's employees. Religiously affiliated non-profits, such as hospitals and schools, also have the option to notify HHS of their objection, and HHS would work with their insurers to continue coverage. The proposed rule also seeks to clarify the definition of a "closely held" business, as this definition varies between federal and state tax codes. These revisions are in response to the Supreme Court's recent <u>Hobby Lobby</u> decision.
