## AAUW Celebrates House Passage of Paycheck Fairness Act

**WASHINGTON ^ July 31, 2008**, AAUW applauds the House of Representatives for passing (247-178) the **Paycheck Fairness Act (H.R. 1338**). If signed into law, the measure would strengthen and update the Equal Pay Act<sup>°</sup> passed 45 years ago<sup>°</sup> and would provide critical tools in the fight to close the sizable wage gap between men and women.

**Championed by Rep. Rosa DeLauro (D-Conn.),** the Paycheck Fairness Act would deter wage discrimination by strengthening penalties for equal pay violations and by prohibiting retaliation against workers who inquire about employers, wage practices or disclose their own wages. Under the bill, employers would have to show that wage gaps truly are the result of factors other than sex discrimination. It would also require the U.S. Department of Labor to reinstate activities that promote equal pay, including collecting wage-related data. The bill had 231 co-sponsors when it passed.

This vote was a fair measure of representatives, stance on pay equity issues, said **Lisa M. Maatz**, AAUW director of public policy and government relations. AAUW will include the vote in our Congressional Voting Record for the 110th Congress, and we,ll make sure our members have the information they need to hold their elected officials accountable. Among their top issues, younger women especially identified equal pay for equal work as a main concern. Concerns over pay equity will be one of the key issues that drives women to the polls, Maatz said. In this economy and this election year, AAUW believes now is the time to address these issues.

## **A NEW DIRECTION FOR LAF**

For a few years now AAUW has been examining ways in which it can be rejuvenated and refocused. It's necessary if it's to retain and expand its membership and to advance its mission. That is, how do <u>we</u> grow into a reinvigorated organization with an expanded purpose? Organizational restructuring was one solution AAUW realized after surveying its members and professionals. It began in 2005 when the AAUW Legal Advocacy Fund (LAF), which was established as a separate corporation, merged with the AAUW Educational Foundation (EF); it's now a major program of the EF.

Then delegates at the 2007 National Convention approved additional changes. The Association (AAUW) and the AAUW EF will combine many of their assets and activities to form a streamlined organization with a single set of elected officers. The new Bylaws will be voted on at the 2009 National Convention to make this official.

In the meantime the focus will be to speak with one voice and one mission. "Breaking through Barriers" will be our new Value Promise, amplifying our Mission Statement of "Advancing equality for women and girls through advocacy, education, and research."

This will mean a new direction for LAF. When it was established in 1981, it focused solely on sex discrimination in higher education, including sexual harassment, pay inequity, denial of tenure and promotion, and inequality in women's athletics programs. LAF has supported more than 100 cases, contributing more than \$1.3 million in direct support to individuals fighting discrimination in the courts.

Earlier this year it was decided to transition LAF to a strategy consistent with our new Value Promise of breaking down educational and economic barriers so that ALL women have a fair chance. This means that LAF will widen its scope beyond the educational setting and use its resources for cases that make legal precedent. This will be a shift for LAF, which has focused more on deserving individuals than on landmark cases with precedent-setting potential.

Until then LAF will continue to direct case funding support for current plaintiffs through December 31, 2008, but will not post for new plaintiff applicants and will not review any current new applicants. Funds are available for the remaining ten of the 14 plaintiffs funded in 2007-8.

What we can do as individual members is make sure LAF has the funds to carry out its work. As Executive Director Linda Hallman writes, "Our members' support is critical! If we are to broaden our focus beyond the academic arena and target our resources to cases that establish significant legal precedent, we must create a fund that will support a significant attack when the "big case" comes along. We will still need to support LAF travel grants and program management, but the real need will be for a "war chest" that we can call upon for strategic litigation."
