#### Legal Advocacy in Action: AAUW Supports Contraceptive Coverage

AAUW signed onto an amicus brief challenging the Trump administration's contraception coverage rules: <u>Massachusetts v. Health and Human Services et al</u> in the U.S. Court of Appeals for the First Circuit. We have previously signed onto similar amicus briefs challenging these rules, as in <u>State of California et al v.</u> <u>Health and Human Services et al.</u>

The Commonwealth of Massachusetts is trying to protect women from the harms that will result from the defendants' attempt to nullify the provisions of the Patient Protection and Affordable Care Act (ACA), which guarantees women equal access to preventive medical care, specifically contraceptive care and services. On October 13, 2017, the defendants, the Secretaries of the U.S. Departments of Health and Human Services, Labor, and the Treasury, as well as their respective departments, issued two Interim Final Rules (IFRs) authorizing employers with religious or moral objections to contraception to block their employees, and their employees' dependents, from receiving health insurance coverage for contraceptive care and services.

The Commonwealth sued to enjoin the IFRs, explaining that the defendants' action will injure the Commonwealth's interests in the health and well-being of its residents. The Commonwealth provided extensive evidence that Massachusetts women will lose contraceptive coverage because of the IFRs and that the Commonwealth will be responsible for providing replacement contraceptive or prenatal care for some of those women through state-funded programs.

The District Court of Massachusetts denied the Commonwealth's motion for summary judgment, finding that the Commonwealth didn't prove the necessary harm to establish standing to challenge the IFRs. On appeal, the Commonwealth seeks the reversal of the district court's ruling, a finding of standing, and a remand of this case to the district court for consideration of the merits of the Commonwealth's claims.

AAUW supports this effort because no-cost contraceptive coverage increases women's ability to participate and succeed in the workplace and helps women reach their aspirations in higher education, which aligns with our core values of access to education, leadership, and economic security.

### **NATIONAL GOALS!!!**

Our new CEO, Kim Churches is responding to our members request that "CLOSE THE PAY GAP" should be foremost in our future. To that end AAUW has just released a free, state-of-the -art online version of the course so it is accessible for more women.

Last year this proven program trained 17,000 women in benefits and salary negotiation. The program works!! 52% of those seeking a new job had been successful in negotiating a higher salary above the initial offer, while hourly workers who participated in a Work Smart workshop are receiving \$2 to \$3 more per hour. Salaried workers are earning 20 to 30 percent more.

THE GOAL IS TO REACH PAY EQUITY BY 2030.

AAUW is working with employers to improve practices and is also fighting to change laws and policies. Over the past two years, more than a dozen pay equity laws have been passed across the country, and this year alone, legislators in 40 states have introduced equal pay bills.

#### AAUW FUNDS - KEEPING THE AAUW MISSION ENERGIZED

#### **NEW MEMBER**




### **BOOK CLUB**
